South Hampstead High School was founded in 1876 with the mission to provide education for all girls, regardless of means.

Up until 1976, and the end of the direct grant system, the Girls' Day School Trust were the largest providers of free, independent school places in the country. Today we can provide only a fraction of this previous support, but we are determined to increase this and ensure that all girls can 'learn without limits' – limits of race, education and, most importantly, limits of financial means.

#### Bursaries at South Hampstead

Currently, just under 4.5% of our Senior School pupils receive means-tested financial support; this is a small fraction of the 35%/40% of pupils who received help at South Hampstead in the
