South Hampstead High School was founded in 1876 with the mission to provide education for all girls, regardless of means. Up until 1976, and the end of the direct grant system, the Girls' Day School Trust was the largest provider of free, independent school places in the country. Today we can provide only a fraction of this previous support, but we are determined to do more.

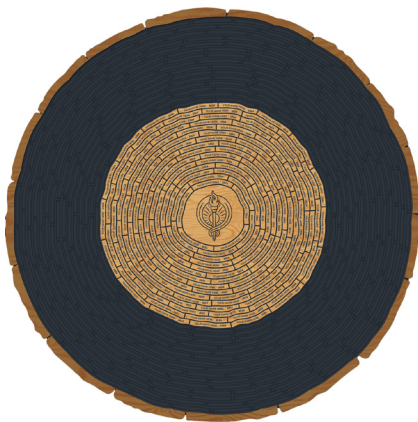
